Greetings and well wishes to all residents.

Once again, the City of Chilton will see a plethora of summer construction as much of the planning in the last year will soon come to fruition. The biggest area this year will be in the vicinity of South Irish Road and Highway 151. South Irish Road is to be urbanized from Hwy 151 extending South to the city limits. Sidewalks are to be installed for your walking pleasure. Bessy Lane will also be completed in the Dairyland subdivision and a new thoroughfare, Geiser Way, is to be created in the recently annexed development property adjacent to Irish Road. Along with the road construction, the city now has thirty new singlefamily homes in Dairyland Estates under contract for construction in the next three years. SC Swiderski will also be starting construction soon on the 102-unit multifamily housing development on the former Geiser property. The city has an agreement with the Town of Charlestown, and for the safety of all drivers and construction workers, there will eventually be a road closure of South Irish Road from Highway 32/57 to Highway 151. The city will do its' best to keep all residents informed of the pending closure.

Congratulations to the Chilton Area School District on the successful passing of both referendums in the April election. All the upgrades to the facilities and the addition of the new sporting complex are great amenities for the City of Chilton which in turn will attract families to this great community. As the school districts use of Morrissey Field ends, the city will be soliciting for public

input for the redevelopment of this area. I hope all residents share their ideas for how this beautiful area is to be shaped for the future.

Parks are an important piece of this community, and the city is currently completing master planning of Riverside and Nennig Parks. New parkland is also being considered for the former Chilton Plating property and some initial design work is also in process. Keeping parkland modern, secure, and accessible is what this planning process is striving to deliver.

Located in this newsletter is information that will allow you as a resident to subscribe for email notifications from the city. You are allowed to pick the category or categories that pertain to you and your families. The information will alert you of city meeting schedules, emergencies, employment opportunities, park and recreation information, future events, and road closures. I suggest all of you take the time to subscribe to these updates and keep yourself informed of city matters.

As always, I want to remind all residents to share input, ideas, and comments with myself, members of the Common Council and the City Hall staff. My office hours at City Hall remain Monday and Wednesday mornings, and Tuesday afternoons. Enjoy the summer months and all that the City of Chilton has to offer.

Building Permit Requirements

What do I need a building permit for?

The City of Chilton requires that no building, plumbing, HVAC, or electrical work shall be performed by any party or be permitted to be performed on the property unless a permit is obtained. Failure to obtain a building permit before commencing with work will result in doubling the permit fee.

Residential Permits

Residential Building Permits are required for work exceeding \$500 in value for building, repair, addition or structural altercation including accessory buildings or fences.

Residential Building permits are required regardless of the cost of the project if any of these are affected:

- Occupancy Area—Kitchen, Bath, Bedroom, Family Room
- Structural Strength—Headers on Bearing Walls
- Fire Protection—Attached Garages/Firewalls
- Exits (Exiting) Porches/Decks
- Ventilation
- Electrical—New/Addition or Removal of Electrical wiring, junction or electric service
- Heating/Ventilating or Air Conditioning
- Plumbing—Removal or changing of water supply lines, drain lines, vents, gas lines or water softeners
- Zoning (Setbacks/Lot Coverage or Height). Signs, fences or pools.

Business Permits

Industrial/Commercial or Business Building Permits are required for work exceeding \$1,000 in value for building, repair, addition, structural alteration, change of use, change of occupancy or change from another use or occupancy to a hazardous use or occupancy.

Electrical, heating, ventilating, air conditioning, or plumbing work involving installing new service, the addition or removal of service or junction boxes, removal or changing of water supply lines, drain lines, vents or gas lines.

Any project requiring architectural drawings, plan submittal or a registered project with the State of Wisconsin will require a building permit.

Recreational Fires

The sights, sounds and smells of summer have returned. Summer activities are in full swing as the temperatures begin to rise with everyone enjoying the joys of Wisconsin nights., which includes summer fires.



12-50 Recreation Fires was established to prevent any outdoor fires from damaging home and other buildings. Rules for recreational fires include:

- No recreational fire shall be closer than twenty (20) feet from any structure.
- No recreational fire shall be in an area larger than 42" x 42".
- Any pit used for a recreational fire shall have a minimum depth of 10 inches and shall be covered when not in use. This pit shall be surrounded on the outside by noncombustible material such as concrete block or rock by a 12" width all around the perimeter.
- All recreational fires shall be contained within the pit or other container in which the combustible material is located
- All recreational fires shall be supervised at all times by at least one person who age is 16 years or older. If not supervised, such recreational fire must be extinguished.
- Combustible material used in recreational fires shall not include rubbish, garbage, treated wood, hazardous materials, flammable, or combustible liquids, vinyl, plastic or rubber materials.
- Police personnel shall have the right to require any fire to be immediately extinguished if the smoke is offensive to surrounding residents or creates a hazardous conditions.
- Portable fire containers shall be located on ground, asphalt, concrete, gravel or pavers.
- Fires permitted between the hours of 1 p.m. and 10 p.m. Sunday— Thursday; 1 p.m. to Midnight Friday and Saturday; Any day/evening preceding a federal holiday; 1 p.m. to Midnight.

Monthly Brush Pick Up

Brush is picked up for residential properties on the fourth Monday of each month on a Call-In basis. To schedule a pick up contact City Hall at (920) 849-2451. Brush must be no larger than 6 inches in diameter, uniformly piled and placed parallel to the street with cut ends lying in the same direction. Residents may bring their loose leaves, brush, branches, shrub trimmings, grass clippings, dirt/sod and garden waste to the City Garage, located at 908 Maple Street (behind Kwik Trip). ITEMS NOT ACCEPTED are any bag or container, rocks/stones, trash or root balls. Residents are also able to pick up wood chips or compost at no charge when available. Yard waste site is open to City of Chilton residents only.

Lawn/Noxious Weeds Maintenance of Vegetation

The City weed ordinance is defined in 18-3 and 18-3 8(a)(b) 12 (b). Noxious weeds and rank growth of vegetation in excess of eight (8) inches in residential areas and 12 inches in undeveloped areas of commercial or industrial zoned properties violates the ordinance. Any property owner who is in violation will receive a notice advising them to cut the weeds or vegetation within three (3) days from the date of the letter. If the weeds or vegetation is not cut the City can cut the weeds or vegetation and invoice the property owner for the service along with the cost of any blades, parts, or equipment that may be destroyed or damaged by any stones or obstacles. The 2022 weed cutting rate is \$80.00 per hour plus a 25% Administrative Fee. The property owner is only notified by letter once during the growing season. If the City received any future complaints, the weeds or vegetation will be cut without any further notification and the cost assessed to the property owner.

Noxious Weeds are defined as "any species of plants, either annual, biennial, or perennial, reproduced by seed, root, underground stem, or bulbet, which then established is or may become destructive and difficult to control by ordinary means of cultivation or other farm practices.



Grass Clippings Compliance

The City of Chilton is mandated by the Wisconsin Department of Natural Resources to assist in improving water quality in lakes, streams and drainage ways into which city storm sewers discharge. Grass clippings can not only clog storm sewers, which can cause localized flooding, but can also cause degradation of water quality of our local rivers and lakes. Police and DPW employees will leave residents a "door
hanger" notice that are not in compliance with this ordinance. Businesses and residents are reminded
when mowing lawn adjacent to the street, direct the lawn mower's discharge chute toward the yard, not
the street. If this cannot be avoided, businesses and residents are required to remove the grass clippings
from the street immediately.

City streets, curbs, gutters and curb inlets are all portions of the storm water system which makes the blowing of grass and leaves onto streets, curbs and gutters illegal and enforceable through the City of Chilton Municipal Code 20-77(b) Littering Prohibited: No person shall cause grass, leaves or any form of yard waste to enter upon public property or upon any private property not owned by said person or upon the surface of any body of water within the city. Per City of Chilton Municipal Code 1-12 violators of this ordinance will be fined in excess of \$200 for each individual violation, in addition to a \$100 clean up fee.

Fall Leaf Collection

Residential leaf collection begins in mid-October and continues up until Thanksgiving, weather permitting.

- Raking leaves into the street is prohibited by law
- Do not put loose leaves at curb until one (1) week prior to date of collection
- Leaves in the street can block storm water inlets, cause flooding and contaminate water. Piles of leaves in the street are also a dangerous attraction to kids
- Bagged leaves will not be picked up by the City
- Brush and leaves should be placed in separate piles to help speed the collection process
- Please refrain from piling yard waste next to trees, poles, mailboxes or other obstructions as this slows down the crews and may cause damage to equipment or obstruction



Garbage/Recycling Pick Up

The City of Chilton has contracted with GFL Environmental for garbage/recycling services. Garbage collection is collected weekly on Tuesdays. No loose trash will be collected outside of the garbage cart. Recycling service is picked up every other week (see schedule listed below). Routes will be pushed back by one day to Wednesday, when it follows a holiday that is observed on the normal service day (those dates are noted with an asterisk (*) on the schedule).

Residents should place their carts to the curb the evening prior to their assigned collection day. Carts need to be placed behind the curb line (out of the road) immediately adjacent to the property. Do not overload your garbage/recycling carts as your lids must close completely. Place your cart 4 feet from other objects on the terrace such as other carts, mailboxes, trees, etc. for the truck arms to grab the cart. Opposite side of driveway is recommended. Do not park vehicles in front or near the cart.

Residents can dispose of large/bulky items either by contacting a contractor of your choosing or haul the item to GFL Hickory Meadows Landfill LLC, W3105 Schneider Rd., Hilbert. Fee may apply. Contact them at (920) 853-8553.

City of Chilton ATV/UTV Usage Ordinance - Effective February 1, 2022

ATV Vehicle Routes: All highways and streets within the City of Chilton that have a speed limit of 35 mph or less are hereby designated as ATV Vehicle Routes

Registration: All ATVs and UTVs utilizing ATV routes shall be registered under §23.33(2) of the Wisconsin Statutes.

Rules of Operation: All of the Rules of Operation described in §23.33(3) and (4) of the Wisconsin Statutes are incorporated herein by reference. In addition, thereto, any person operating on an ATV Vehicle Route must:

- (a) Be at least 16 years of age and possess and carry a valid Wisconsin driver's license which has not been suspended or revoked.
- (b) Possess and carry proof of liability insurance as is required for a valid Wisconsin driver's license.

Equipment Requirements: All of the Equipment Requirements described in §23.33(6) of the Wisconsin Statutes are incorporated by reference.

Noise Limits. The Noise Limits described in §23.33(6m) of the Wisconsin Statutes are incorporated by reference.

Passenger Restriction. The Passenger Restrictions described in §23.33(6r) of the Wisconsin Statutes are incorporated by reference.

UTV Specifics

- All UTV passengers must have their seatbelts fastened at all times.
- No person may ride in or on any part of the UTV that is not designed or intended to be used by passengers.
 Aftermarket seating does not comply with the new law change.

ATV/UTV Laws

- ATVs and UTVs are required to have a lighted headlamp and tail lamp at all times during operation.
- Both passengers and operators in Wisconsin must wear a helmet on both ATVs and UTVs if they are under the age of 18. Exemptions—Supervised on private lands and traveling to/from hunting and fishing if between 12 and 18 years old.
- Helmet must be DOT approved.

Time to clean out the cupboards and dispose of any unused medicines properly! Calumet County Drug Disposal Program is accepting unused and/or expired medications, over the counter medications, prescription medications and pet medications at no charge.


Guidelines

Accepted drugs include prescriptions, over the counter, pet medications, controlled substances and supplements.

- Place pills in a "Ziplock" style bag that is quart size or less. Pills can be mixed into one bag
- Liquids, cremes, and powders can stay in the original container with caps tightened
- Recycle pill bottles and boxes in your home recycling as they are NOT accepted

Needles, sharps, mercury devices, chemical waste, electronic glucose monitors, non-medical inhalers, and personal care products like shampoo and cosmetics will not be accepted. Contact the Calumet County Health Department at (920) 849-1432 for safe disposal.

Never dispose of these items in your curbside recycling or garbage collection.



Fireworks Safety

Fireworks are often used to mark special events and holidays. However, they are not safe in the hands of consumers. Fireworks cause thousands of injuries each year. People enjoy fireworks safely if they follow a few safety tips:

- Do not use consumer fireworks
- Keep a close eye on children at events where fireworks are used.
- Never throw or point fireworks at anyone.
- Never allow young children to play with or ignite fireworks
- Obey all local laws regarding the use of fireworks.



Reminders for Pet Owners

As the weather gets nice, more pet owners will be out walking with their four legged friends.

Here are a few reminders for pet owner's:

 4-1: Dog license year commences January 1



and ends on the following December 31. Dog licenses are required within 30 days after a dog reaches 5 months of age. Dog licenses are required annually by paying the dog license tax provided in Wisconsin State Statutes Sec. 174.05.

 4-7(a)(b) Dogs Running at Large: No person who owns, harbors, keeps, or has under his or her control a dog, cat or other animal shall permit the same to run at large in the city at any time. Each person of such animal shall confine it within the limits of his/ her premises except when it is attended by some person, and fastened securely by a suitable leash not more than ten (10) feet in length. For the purpose of this section, the phrase "running at large" includes all places within the City except the owner's premises. Picks up and properly disposes of any animal waste which may be excreted by the animal. Proper container shall be interpreted to be a pail, bag, box or other object of non-porous material suitable for holding animal waste.

18-5(16): Barking Dogs: Harboring certain animals prohibited. No person shall own, harbor, or keep any, dog, cat or any other animal which habitually makes noise to the annoyance of two (2) or more individuals residing in separate households.

When summer heats up, so do our cars. Every year, dogs and children die when left unattended in overheated cars. A car can become an oven in a matter of minutes. The temperature outside may be misleading. On a 78-degree day, the temperature inside a parked car can jump to 120 degrees in just minutes. Even with the windows rolled down part way the temperatures can get dangerously high. Also remember to consider the effect of summer heat on pavement, as well. If you like to walk your pets, check the pavement temperature by pressing the back of your hands to the surface for 10 seconds. If it becomes too hot for you, then it is too hot for your pet and may burn their

If you have a choice, on warm days leave companion animals home rather than leave them in the car when you are doing errands.

Do You Have a Water Leak?

If your water bill seems

high, it may be a result of leaks in your plumbing. Many people do not realize that even small leaks can add hundreds or thousands of gallons onto each water bill. A running toilet can waste up to 200 gallons of water per day and a single faucet leaking one drip per minute can add over 500 gallons to your quarterly water bill. Water softeners can also waste a lot of water if they regenerate too often or are otherwise malfunctioning. You cannot see these leaks as they drain directly to the sewer; accordingly that water is not only wasted, but also needs to be treated. Please check your plumbing for leaks. It could save you money on your water and sewer bill!

Utility Billing When Buying or Selling a Home

When buying/selling a home in the City of Chilton please keep the following in mind regarding utility billing:

Seller's Responsibility:

- Notify City Hall to have your name removed from the quarterly bill.
- Provide a forwarding address and a move-out date.

Buyer's Responsibility:

- Notify City Hall to sign up for service.
 The following information is needed:
 - ~ Name on Account
 - ~ Property Address
 - ~ Your mailing address for billing
 - ~ Property closing date
 - ~ Phone Number

Transferring Service:

- Notify City Hall to have your service transferred from one location to another
- Please make sure your account information and payments are up to date.

Utility Bill Late Payments

- Wisconsin State Statue 66.0809 requires municipalities to place delinquent water bills on the tax roll as a tax against the property that was furnished with utility service.
- One or before October 15 of each year, the Utility will send past due notices to the tenants and the landlords giving them 14 days to pay their overdue utility bill. If payment is not made within the 14 days, a 10% penalty will be added to the past due amount and the total will be placed on the landlord's property tax bill.

Utility Bill Payment Options

- Auto Pay: FREE SERVICE for Water/Sewer bill payments only. Payments are automatically deducted from checking/savings account each quarter. You still receive your quarterly bill and funds are withdrawn from your account on the due date that appears on your bill. Contact City Hall for more information.
- Drop Box: Located left of City Hall main doors.
- Drop Off: City Hall, 42 School St., 7:30 a.m.— 4:30 p.m. Monday thru Thursday; 7:30 a.m.—1 p.m. Friday.

City of Chilton Memorial Tree Program

A tree is a perfect way to honor a person and help the community. The tree will be planted by the city in the name of the honoree at one of Chilton's park. Purchasers can select the tree species or the Chilton Tree Board will assist in making the tree selection. Orders received by September 1st will be planted in late September or early October. Memorial Trees are approximately 1—2 1/2" caliber trees, with a minimum purchase price of \$225, plus an Administrative Fee of \$20.

In addition a memorial leaf/plaque can be purchased. Contact City Hall for further details.

Guidelines for Swimming Pools

A building permit is required and shall be obtained for the installation of all new, remodeled, altered or relocated private pools in the City of Chilton. The application for a permit shall be accompanied by a plot plan drawing of the premises upon which the proposed pool is to be installed. The plot plan shall show the size and shape of the lot location and size of all buildings, structures and fences existing or prosed and any other information affecting the premises. The plot plan shall be accurate and dimensioned.

All private residential pools whether in ground or above ground, shall be enclosed with an adequate and secure fence at least 42" high above adjoining grade to prevent straying into pool area. Fences shall be constructed to prohibit the passage of a four inch spere between fence members. Any gate installed shall be provided with self-closing and self-latching devices, which shall be on the inside of the gate at least 30" above ground level.

Exterior Storage and Parking

Projects are always in full force, but especially during the summer months! These ordinance reminders are designed to prevent and eliminate conditions that cause urban blight.

40-109 Exterior Storage in Residential Districts: All materials and equipment shall be stored within a building or fully screened so as not to be visible from adjoining properties except for the following; laundry drying and recreational equipment, construction, and landscaping materials and equipment currently being used on the premises, agricultural equipment and materials if these are used or intended for use on the premises.

Boats and unoccupied trailers, less than 30 feet in length, are permissible if stored in the rear yard more than 5 feet from any property line on an impervious surface and moved every 12 months.

Seasonal storage of boats and unoccupied trailers, less than 30 feet in length is permissible on a side yard (not street side) on an impervious surface.



No person shall park a vehicle, boat or trailer on a front yard or street side yard of any lot used primarily for residential purposes. All parking is required to be on an impervious surface and on an approved driveway per Municipal Code 40-109 Performance Standards.



lm-

pervious surfaces means any hard surface that prevents or hinders the absorption of water into the soil, or that causes reduced quality of runoff water, or causes water to runoff in greater quantities or at greater flow rates than the natural surface. All impervious surfaces MUST BE APPROVED THROUGH CITY HALL.
